- Co-operation in the neighbouring areas (Karelia)





We promote children's rights!

By

- making the Convention of the Rights of the Child known to children, adults and decision-& policy-makers at all levels of decision-making (including EU!)
- monitoring the implementation of the CRC
- participation in the process of reporting to the Committee on CRC
- the best interests of the child as a guiding principle







CRC Reporting Process in Finland during the 4th periodic review process

- 1. Early 2008: the state party starts to prepare its report; deadline November 2008
 - Consults the NGO community and organises a hearing
- 2. NGO Group informs CUCW about the arrival of the state report and advices the NGO community to start working on its report
 - Preparations of the NGO Supplementary report starts

Positive facts presented in the Report (October 2010)

- 1.New Child Welfare Act improved children's rights in Finland
- 2.Child-friendly policies introduced in the State administration
- 3.Awareness of the UN CRC increased and the National Communications Strategy on children's rights was finalised



Supplementary NGO report to Finland's 4th periodic report on the implementation of the UN Convention on the Rights of the Child

Issues of concern

- 1. The state supervision system is insufficient
- 2.The best interests of the child is not sufficiently implemented
- 3.A part of young are facing problems
- 4.Adults' heavy substance abuse complicates the lives of children
- 5.The financial situation of families with children has deteriorated
- 6.Integration of immigrants has not been successful
- 7. Teaching childrens' rights has not been done in schools

CRC Reporting Process in Finland during the 4th periodic review process

- 3. Setting up the NGO delegation for Geneva (Feb 8, 2011)
 - 8 members nominated by the CUCW board
 - Division of work and themes
 - 2 meetings
 - Preparation of the Introductory Statement
- 4. Pre-sessional working group with the UNCRC Committee
 - Joint press releases



CRC Reporting Process in Finland during the 4th periodic review process

- 5. Children's consultation
 - Organised in Finland (May 11, 2011)
 - Co-operation with the ombudsperson for children and UNICEF Finland
 - Inviting the state rapporteur from the UNCRC Committee
 - Inviting children: contact persons/group
 - Preparing child-friendly material
 - Meeting organised with an interpreter
 - Total of 20 children and young persons representig the Roma, the Sami, Finnish Children's Parliament, the Survivors group, a regional youth council and the young advisors of the ombudsperson for children

- 5. The State party session (June 9, 2011)
 - Observers
- 6. Concluding observations (June 20, 2011)
 - Joint press release
 - Dissemination of information to members
- 7. Keeping discussion and advocacy work alive (next state report in 2017!)
 - New government programme (June 17)
 - Universal Periodic Review, UPR (Finland in May 2012)
 - Activities of Advisory Boards in CUCW
 - Continuous link to advocacy work
 - Training
