Programme

Background

The possibilities and limits of socio-pedagogical work with children and juveniles in “secure accommodation” has been the subject of controversy for many years. As a matter of fact, there are institutions and forms of “secure accommodation“ in all European countries and, for certain juveniles, measures depriving or reducing freedom or liberty are regarded as useful. A key thought here is that for children and juveniles a limiting institutional framework in space and time is established in which they cannot withdraw from a given binding pedagogical contact and as such, alter their behaviour with regards to conflict solution. Besides providing protection through a closed institution, the benefit of a secure framework is seen as, providing an opportunity for confrontation and discussion.

The main focus of the meeting will be to take stock of: 1) in a comprehensive way, the different legal frameworks; (2) institutional and technical evolutions which are taking place in this field; and (3) research results in socio-pedagogical intervention. During expert discussions, results of examinations, surveys and evaluations of different socio-pedagogical concepts of closed institutions in different European countries (namely Germany, Switzerland, Denmark, Bulgaria) will be presented and discussed.

How the topic relates to Luxembourg:

During the meeting, the topic of secure accommodation of, and coercive/restrained settings for, children and juveniles will be addressed, a subject that has been periodically debated in the media and in politics for a number of years. As early as 1994, the government announced the creation of a closed institution for children and juveniles. In 2004, a law on the construction of a closed institution „security unit“ (“Unité de sécurité”, Unisec) in the „socio educative home of the State“ in Dreibern was adopted.¹ Until the completion of this project, in the frame of „juvenile protection measures“, minors had been referred by the juvenile courts to a closed wing in the adult prison in Schrassig.

The infrastructural project for an “Unité de sécurité” launched in 2004 is currently under construction, despite the lack of a conceptual frame for the future of pedagogical-therapeutic and psycho-social work. That is why the organisers of the meeting expect that the scientific exchange between experts will provide a helpful stimulus that will shape the debate in an enriching way.

In addition, this expert meeting is a continuation of the meeting „Youth Care – Youth punishment: dealing with child and juvenile delinquency in a European perspective“, which took place from 30.11 to 2.12.2000 in Luxembourg. The meeting was organised by FICE-Europe in cooperation with the German Association for Juvenile Courts, the ANCE (L), and the IGfH (D). The meeting provided a European stock-taking that is documented.²



Aims of the Meeting

The meeting deals with and aims to:

1. Take stock in several countries of the:
 - Developments in the area of secure detention and coercive/restrained settings, as well as pedagogical work with juveniles
 - Different requirements and/or prerequisites
 - Legislation, infrastructures and institutions
2. Socio-pedagogical/social work (educative measures) with the following target groups:
 - Violence prone juveniles
 - Juvenile offenders
 - Non-cooperative juveniles
3. Clarify to what extent the continuation of a perspective encompassing several European countries is useful, as well as
4. Clarify which use is generated out of this meeting for professional practice – good practices, standards etc.

Thematic Panels

The meeting will be structured as follows:

- Panels of two hours each
- Per panel:
 - **Short interventions** (+/- 10 minutes), if possible, **of all national representatives: Panel I + II**
 - **Contributions** (+/- 15 minutes) of different **national representatives** and spontaneous short contributions other national representatives: **Panel III + IV + V**
 - Participation, if possible of all national representatives in the discussion
 - Transversal perspective by Dr. Philipp Walkenhorst (parallels and divergences with juvenile penal system) and by Dr. Ton Liefwaard

Panel I: Legal frame for the work with juveniles in the context of secure detention and in coercive/restrained settings

1. What is the **legal basis** for work in the context of secure detention and coercive/restrained settings?
2. What **target groups** are being addressed (recording of statistical data)? What are the **most common categories of problems or problematic cases** that you have encountered in secure detention and/or in coercive/restrained settings?
3. What **social objectives** (e.g. which systemic relation: child/juvenile assistance, child/juvenile psychiatry, justice) are linked to the legal basis?
4. Are there human right **quality standards** such as e.g. the UN Convention of the Child, esp. Article 37 that apply?
5. Who or what institution (e.g. court, magistrate, specially foreseen commission, director of an institution) can a) make an **application for secure detention and coercive/restrained settings** and b) has the **decision** making power in such cases?
6. What is the **procedure** between decision for secure detention or coercive/restrained setting of a juvenile and when does this procedure begin? In case of secure detention or coercive/restrained setting, is a police intervention foreseen or is it handled by staff of the institution?
7. What is the **maximum duration of stay** foreseen for a secure detention or a coercive/restrained case?
8. Is there a **gap between the legal framework and field practice**? If so, in what areas? Is this discrepancy acknowledged by the national authorities and if so, what measures are being taken in this regard?
9. Is there a **right of appeal** against secure detention or coercive/restrained setting and if so, through what type of procedure?
10. Does secure detention or coercive/restrained settings influence **visiting rights** of family and friends and if so, to what extent?
11. Does the law provide for a **termination of secure detention or coercive/restrained setting prior to their expiration** and which institution or person a) can apply for it and b) has the decision-making power?
12. During secure detention, is the juvenile allowed to spend **time outside of his room/cell** and, if so, how is this regulated? What are the juvenile's rights with regards to leaving his room/cell (in a courtyard, alone, together with others...) during secure detention?
13. Other relevant information regarding secure detention and/or coercive/restrained settings?

Panel II: Research

1. Which kind of **research** is conducted in your country?
2. What research themes and questions are predominant in your national policy discourse?
3. Based on the research results, can one draw broad conclusions with regards to **structures and concepts** of secure detention and coercive/restrained settings?
4. Is there a **dialogue** in your country **between research and practice**? If so, in what form?

5. Does research provide evidence with regards to the **integration of secure detention and coercive/restrained settings into a general concept of juvenile assistance**?
6. **Who finances research** (state, ministries, NGOs, private donors...)?
7. If there is no research: what would be necessary to trigger the **interest of national authorities and/or other potential donors** in research on secure detention and coercive/restrained settings?

Panel III: Pedagogical concepts – structures and organisational forms

1. What **methodological basis** (e.g. confrontational pedagogy, multi module care...) and what institutions are present in your country (overview)?
2. In which cases are secure detention and a coercive/restrained settings used?
3. What **duration of stay** is foreseen or practice in the respective institutions?
4. What is the composition of the **teams** (professional profiles, number of staff)?
5. Does **staff** working in the area of secure detention and coercive/restrained settings undergo **special trainings** such as suicide prevention, drug awareness training, behavioural training with regards to aggressive juveniles...?
6. What **in house training or further education** is used by the professionals in the field; how is this financed?
7. Is this **in house training or further education** occurring on a **voluntary basis or does it take place as part of the work schedule**?
8. What **institutions dealing with secure detention and coercive/restrained settings** cooperate among each other and in which form, in order to assist juveniles in the most efficient way before during and after time in secure detention and coercive/restrained settings?
9. Is there any kind of **cooperation with psychiatric institutions** and, if so, in which form?

Panel IV: Pedagogical concepts –Methods and Instruments

1. **Diagnosis, evaluation and documentation** in den the respective areas?
2. How is **social and psychopedagogical work** recorded (education, intervention plans...)?

Background of Keynote Speakers

- **Prof. Dr. Michael MACSENAERE**, PhD in Psychology with specialisation in sports' psychology. Michael Macsenaere is Director of the *Institut für Kinder- und Jugendhilfe (IKJ)* in Mainz, an external practical social science research institute. His research priorities are in the area of evaluation of educative care, quality development, as well as resource-oriented pedagogy and in sports' psychology. Dr. Macsenaere is best known for his empirical impact-research in child and youth care namely in the area of secure detention.

- **Prof. Dr. Sabine PANKOFER**, PhD and M.A. in Psychology, alternative pedagogy and sociology. She has several years of practical experience in different fields of juvenile work, including teaching and research. Sabine Pankofer's PhD research dealt with secure detention for girls. Since 1998, she is Professor of Psychology and Social Work at the *Katholische Stiftungsfachhochschule* in Munich where she is, inter alia, a supervisor and trainer. Her expertise is in the area of youth care, gender youth work, juvenile delinquency, female aggression social psychology and practical research.

- **Prof. Dr. Philipp WALKENHORST**, PhD Pedagogy, Graduate Social Scientist; 1982-2005 Assistant in the field of Rehabilitation and Pedagogy with Mentally and Behavioural Disorders, Faculty of Rehabilitation Sciences, University of Dortmund. Since 2006, Chair of Child & Youth Support and Social Work, Faculty of Social Sciences, Department Therapeutic Pedagogy and Rehabilitation, University of Cologne. Fields of expertise: Pedagogy of juvenile delinquents, Youth Violence, Prevention & Intervention in Social Pedagogy. Cooperation with (special-) schools and youth welfare/social work at school, education in youth prisons and short term sentences. Expert member of the committee of enquiry for an effective prevention policy in North Rhine-Westphalia, founded in 2008.
